Representative Cases & Matters

- Represented clients in breach of contract and Washington State Securities Act claims against health clinic; obtained judgment of over \$33 million after arbitration that was confirmed by the court.
- Represented doctor in retaliation and breach of contract related claims against hospital; obtained an award of \$18.2 million in damages and attorney's fees and costs after a hard fought arbitration, and argued the appeal before the Court of Appeals, which confirmed the award.
- Represented clients in defending against wage withholding claim; obtained full defense verdict and a fee award after three week jury trial.

- Represented a lawyer in a malpractice and breach of fiduciary duty action arising out of tax-related advice. After a lengthy jury trial, she obtained a favorable verdict that was upheld on appeal.
- Represented manager in lengthy multi-party jury trial over the course of six weeks. Obtained a unanimous jury verdict on manager's defamation claims, defeating false accusations of sexual harassment, retaliation, and related claims.
- Represented majority shareholders in a closely held company in expedited arbitration arising out of a dispute over the purchase of the company. After expedited arbitration, she obtained a favorable verdict that included a fee award.



- Represented defendant in a dispute involving claims for equitable lien, intentional interference with contractual relationships, conversion, and unjust enrichment. After winning summary judgment at the trial level, the result was affirmed on appeal. - Represented a law firm in fee dispute and malpractice counterclaims. She prevailed on summary judgment, which was upheld on appeal.
- Represented a bank in a case alleging unlawful discrimination. After a multiweek jury trial, she settled the case favorably prior to closing arguments.
- Represented a local charity in TEDRA litigation relating to a family's challenge to a decedent's charitable gift. She resolved the case favorably for her client in an expedited time frame.
- Represented majority shareholders in a minority shareholder oppression and breach of fiduciary duty case; obtained a full defense verdict after a multiweek jury trial.
- Represented a doctor in a dispute with a local hospital over removal of privileges, prevailing after a multiday internal hearing process.
- Represented a local business and an employee in a dispute with a competitor over the terms of a non-compete agreement. She settled the case favorably for her client.
- Represented a developer in cross-suits with a lender relating to various projects. She settled the case in her client's favor shortly before trial.
- Represented a lawyer in a malpractice and breach of fiduciary duty claims relating to a real estate development. The case was dismissed on summary judgment.
